Entitlement to Participate and Appointment of Proxy

Only members whose names appear on the Record of Depositors as at 18 August 2023 shall be eligible to attend, speak
and vote at the 26th AGM or appoint a proxy(ies) and/or the Chairman of the Meeting to attend and vote on his/her behalf.

- If you are unable to attend the meeting on 30 August 2023, you may appoint the Chairman of the meeting as proxy and
 indicate the voting instruction in the Proxy Form.
- If you wish to participate in the 26th AGM yourself, please do not submit any Form of Proxy for the 26th AGM. You will not be allowed to participate in the 26th AGM together with a proxy appointed by you.
- Accordingly, proxy forms and/or documents relating to the appointment of proxy/corporate representative/attorney for the 26th AGM whether in hard copy or by electronic means shall be deposited or submitted in the following manner not later than Monday, 28 August 2023 at 10.00 a.m.:

Select the "Sign Up" button and followed by "Create Account by Individual Holder". Please refer to the tutorial guide posted on the homepage for assistance.
	 Registration as a user will be approved within one (1) working day and you will be notified via e-mail. If you are already a user with TIIH Online, you are not required to register again.
Proceed with submission of Proxy Form	 After the release of the Notice of Meeting by the Company, login with your user name (i.e. email address) and password. Select the corporate event: QL Resources 26th AGM - "Submission of Proxy Form". Read and agree to the Terms and Conditions and confirm the Declaration. Insert your CDS account number and indicate the number of shares for your proxy(s) to vote on your behalf. Indicate your voting instructions - FOR or AGAINST, otherwise your proxy will decide on your votes. Review and confirm your proxy(s) appointment. Print the form of proxy for your record.

ii. Steps for corporation or institutional shareholders Register as a User Access TIIH Online at https://tiih.online with TIIH Online Under e-Services, the authorised or nominated representative of the corporation or Website institutional shareholder selects "Create Account by Representative of Corporate Holder". Complete the registration form and upload the required documents. Registration will be verified, and you will be notified by email within one (1) to two (2) working days. Proceed to activate your account with the temporary password given in the email and re-set your own password. Note: The representative of a corporation or institutional holder must register as a user in accordance with the above steps before he/she can subscribe to this corporate holder electronic proxy submission. Please contact our Share Registrar if you need clarifications on the user registration. Proceed with Login to TIIH Online at https://tiih.online submission of Select the corporate exercise name: "QL Resources 26th AGM: Submission of Proxy Proxy Form Form". Agree to the Terms & Conditions and Declaration. Proceed to download the file format for "Submission of Proxy Form" in accordance with the Guidance Note set therein. Prepare the file for the appointment of proxies by inserting the required data. Submit the proxy appointment file. Proceed to upload the duly completed proxy appointment file. Select "Submit" to complete your submission. Print the confirmation report of your submission for your record.
